CONSENT AGREEMENT AND ORDER

WHEREAS, COURTNEY NEWCOMER (“MS. NEWCOMER”) is a Licensed Behavior Analyst (“LBA”), and is subject to the jurisdiction and rules and regulations of the Behavior Analyst Practice Act (La. R.S. 37:1001, et seq.), the Professional and Occupational Standards for Behavior Analysts (LAC 46:VIII §301, et seq.), the BACB Professional and Ethical Code for Behavior Analysts, and the rules regarding disciplinary proceedings (LAC 46:VIII §601, et seq.);

WHEREAS, the Louisiana Behavior Analyst Board (“LBAB”) received information indicating that MS. NEWCOMER allowed an individual who was not registered with the LBAB to engage in providing applied behavior analysis services to clients from September, 2020 to December, 2020;

WHEREAS, by correspondence dated March 9, 2021, the LBAB notified MS. NEWCOMER of the Board-initiated complaint filed against her, provided MS. NEWCOMER with a summary of the nature of the complaint, and requested that MS. NEWCOMER, within thirty (30) days, provide a statement giving her review of the circumstances that are the subject of the complaint;

WHEREAS, by letter dated April 5, 2021, MS. NEWCOMER provided a response to the complaint, giving her review of the allegations set forth therein;

WHEREAS, the respondent, COURTNEY NEWCOMER, has indicated her desire to resolve this matter through a Consent Agreement and Order provided for in LAC 46:VIII §603 and La. R.S. 49:955(D) of the Louisiana Administrative Procedure Act;

WHEREAS, the Respondent, COURTNEY NEWCOMER, has admitted the following:

1. Respondent, COURTNEY NEWCOMER, is and was at all times pertinent to the facts and matters alleged herein, a Licensed Behavior Analyst, licensed by the LBAB to engage in the practice of behavior analysis in the State of Louisiana, as evidenced by LBA License Number L-423.
2. At all times pertinent to the facts of this case, MS. NEWCOMER was actively engaged in the practice of Applied Behavior Analysis in West Monroe, Louisiana, at The Behavior Train.
3. The Respondent, COURTNEY NEWCOMER, acknowledges that the LBAB may have sufficient information to file an Administrative Complaint based upon the allegations against her as addressed in the March 9, 2021 notice letter from the LBAB. Thus, to avoid proceeding to an administrative hearing, Respondent agrees to the terms of this Consent Agreement and Order.
4. The Respondent, COURTNEY NEWCOMER, admits that her conduct violated the following rules and regulations of the LBAB: La. R.S. 37:3712(B)(12)(15), BACB Rules 7.01, 10.06, LAC 46:VIII §304, and §1001.

WHEREAS, the Respondent, MS. NEWCOMER, agrees not to repeat the misconduct mentioned in this Consent Agreement and Order and acknowledges that any further misconduct mentioned in this Consent Agreement and Order will be considered a violation of the terms of this Consent Agreement and Order and shall be cause for further disciplinary action. MS. NEWCOMER further recognizes that any violation or failure of strict compliance with any of the terms and conditions set forth in this Consent Agreement and Order by MS. NEWCOMER shall be deemed adequate and sufficient cause for the LBAB to immediately suspend the license of MS. NEWCOMER to practice behavior analysis in the State of Louisiana for a period of up to two (2) years, as determined by the LBAB at a regularly scheduled meeting of the LBAB, without the need to institute new disciplinary proceedings against MS. NEWCOMER.

WHEREAS, Respondent, MS. NEWCOMER, recognizes her right to have an administrative adjudication of the charges outlined in the complaint and notice letter, at which time MS. NEWCOMER would be entitled to be represented by legal counsel, to call witnesses, and to present witnesses on her behalf in defense or in mitigation of the charges made, and to a decision thereon by the LBAB based upon written findings of fact and conclusions of law in accordance with the Louisiana Administrative Procedure Act. MS. NEWCOMER nonetheless hereby waives her right to formal adjudication and, pursuant to La. R.S. 49:955(D), consents to the entry of the Consent Agreement and Order set forth hereinafter. MS. NEWCOMER also acknowledges that she hereby waives any rights to which she may be entitled pursuant to the Louisiana Administrative Procedure Act, La. R.S. 49:951, et seq., or which she otherwise may be afforded by any law to contest her agreement to, or the force and effect of this Consent Agreement and Order in any Court or other forum and further waives the right to appeal the approval of this Agreement by the LBAB.

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the LBAB by La. R.S. 49:955(D), the LBAB orders and MS. NEWCOMER accepts the following administrative action, which is a final decision pursuant to La. R.S. 49:958:

1. The LBAB license of MS. NEWCOMER to be engaged in the practice of Applied Behavior Analysis in the State of Louisiana, as evidenced by the LBA License Number L-423, shall be, and is hereby REPRIMANDED, based upon the allegations of the complaint and investigation. MS. NEWCOMER accepts and shall maintain strict compliance with the following terms and conditions.
2. MS. NEWCOMER shall pay legal costs associated with the Complaint in the amount of SIX HUNDRED DOLLARS (\$600.00) as well as a fine as authorized by La. R.S. 37:3704(8) and La. R.S. 37:3712(C) for the above referred violations in the amount of TWO HUNDRED DOLLARS (\$200.00) within six (6) months from the date that all parties sign this Consent Agreement and Order, which payment shall be made by certified check or money order. The payment(s) shall be made in five installments of \$133.33 and a final installment of \$133.35, postmarked no later than the tenth (10th)

day of each month, with the first payment due within thirty (30) days after the approval of this Agreement by the LBAB. There shall be no pre-payment penalty.

3. MS. NEWCOMER shall participate in and cooperate with a practice and process audit by the LBAB Complaints Coordinator. She shall promptly provide any information requested in association with the audit.
4. MS. NEWCOMER shall report the terms of this Agreement to any Board or Agency by which she is licensed, as well as the BACB.
5. Any violation or failure of strict compliance with any of the terms and conditions set forth in this Consent Agreement and Order by MS. NEWCOMER shall be deemed adequate and sufficient cause for the LBAB to immediately suspend the license of MS. NEWCOMER to practice Applied Behavioral Analysis in the State of Louisiana for a period of up to two (2) years, as determined by the LBAB.






