CONSENT AGREEMENT AND ORDER

WHEREAS, JERRICK COMEAUX (“MR. COMEAUX”) is a Licensed Behavior Analyst (“LBA”), and is subject to the jurisdiction and rules and regulations of the Behavior Analyst Practice Act (La. R.S. 37:1001, et seq.), the Professional and Occupational Standards for Behavior Analysts (LAC 46:VIII §301, et seq.);

WHEREAS, the Louisiana Behavior Analyst Board (“LBAB”) received information indicating that MR. COMEAUX may have allowed an individual who had started but had not finished completion of the registration process with the LBAB to engage in providing applied behavior analysis services to clients;

WHEREAS, by correspondence dated January 25, 2023, the LBAB notified MR. COMEAUX of the Board-initiated complaint filed against him on January 4, 2023, provided MR. COMEAUX with a summary of the nature of the complaint, and requested that MR. COMEAUX, within thirty (30) days, provide a statement giving his review of the circumstances that are the subject of the complaint;

WHEREAS, by letter received by the LBAB on February 13, 2023, MR. COMEAUX provided a response to the complaint, giving his review of the allegations set forth therein;

WHEREAS, the respondent, MR. COMEAUX, has indicated his desire to resolve this matter through a Consent Agreement and Order provided for in LAC 46:VIII §603 and La. R.S. 49:955(D) of the Louisiana Administrative Procedure Act;

WHEREAS, the Respondent, MR. COMEAUX, has admitted the following:

1. Respondent, MR. COMEAUX, is and was at all times pertinent to the facts and matters alleged herein, a Licensed Behavior Analyst, licensed by the LBAB to engage in the practice of behavior analysis in the State of Louisiana, as evidenced by LBA License Number L-647.
2. At all times pertinent to the facts of this case, MR. COMEAUX was actively engaged in the practice of Applied Behavior Analysis in Lafayette, Louisiana, at Therapy Center of Acadiana.
3. The Respondent, MR. COMEAUX, without admitting any violation of any law, regulation, and/or rule, acknowledges that he unintentionally allowed an unregistered individual who had started but not yet completed the registration process to provide behavior analysis services to clients for a period of six months.
4. The Respondent, MR. COMEAUX, without admitting any violation of any law, regulation, and/or rule, acknowledges that the LBAB may be able to prove that the LBAB may be able to prove that his conduct may have violated the following rules and regulations of the LBAB: La. R.S. 37:3716(A)(4), and LAC 46:VIII §304.

WHEREAS, the Respondent, MR. COMEAUX, agrees not to repeat the alleged misconduct mentioned in this Consent Agreement and Order and acknowledges that any further misconduct mentioned in this Consent Agreement and Order will be considered a violation of the terms of this Consent Agreement and Order and shall be cause for further disciplinary action. MR. COMEAUX further recognizes that any violation or failure of strict compliance with any of the terms and conditions set forth in this Consent Agreement and Order by MR. COMEAUX shall be deemed adequate and sufficient cause for the LBAB to immediately suspend the license of MR. COMEAUX to practice behavior analysis in the State of Louisiana for a period of up to two (2)

years, as determined by the LBAB at a regularly scheduled meeting of the LBAB, without the need to institute new disciplinary proceedings against MR. COMEAUX.

WHEREAS, Respondent, MR. COMEAUX, recognizes his right to have an administrative adjudication of the charges outlined in the complaint and notice letter, at which time MR. COMEAUX would be entitled to be represented by legal counsel, to call witnesses, and to present witnesses on his behalf in defense or in mitigation of the charges made, and to a decision thereon by the LBAB based upon written findings of fact and conclusions of law in accordance with the Louisiana Administrative Procedure Act. MR. COMEAUX nonetheless hereby waives his right to formal adjudication and, pursuant to La. R.S. 49:955(D), consents to the entry of the Consent Agreement and Order set forth hereinafter. MR. COMEAUX also acknowledges that he hereby waives any rights to which he may be entitled pursuant to the Louisiana Administrative Procedure Act, La. R.S. 49:951, et seq., or which he otherwise may be afforded by any law to contest his agreement to, or the force and effect of this Consent Agreement and Order in any Court or other forum,

IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the LBAB by La. R.S. 49:955(D), the LBAB orders and MR. COMEAUX accepts the following administrative action, which is a final decision pursuant to La. R.S. 49:958:

1. The LBAB license of MR. COMEAUX to be engaged in the practice of Applied Behavior Analysis in the State of Louisiana, as evidenced by the LBA License Number L-647, shall be, and is hereby REPRIMANDED, based upon the allegations of the complaint and investigation. MR. COMEAUX accepts and shall maintain strict compliance with the following terms and conditions.

2. MR. COMEAUX shall pay legal costs associated with the Complaint in the amount of THREE HUNDRED DOLLARS (\$300.00) as well as a fine as authorized by La. R.S. 37:3704(8) and La. R.S. 37:3712(C) for the above referred violations in the amount of THREE HUNDRED DOLLARS (\$300.00) within six (6) months from the date that all parties sign this Consent Agreement and Order, which payment shall be made by certified check or money order. The payment(s) shall be made in six installments of \$100.00, postmarked no later than the tenth (10th) day of each month, with the first payment due within thirty (30) days after the approval of this Agreement by the LBAB. There shall be no pre-payment penalty.
3. MR. COMEAUX shall participate in and cooperate with a practice and process audit by the LBAB Complaints Coordinator. He shall promptly provide any information requested in association with the audit.
4. MR. COMEAUX shall report the terms of this Consent Agreement and Order and its approval to any board or agency located in the United States with which he is professionally credentialed.
5. Any violation or failure of strict compliance with any of the terms and conditions set forth in this Consent Agreement and Order by MR. COMEAUX shall be deemed adequate and sufficient cause for the LBAB to immediately suspend the license of MR. COMEAUX to practice Applied Behavioral Analysis in the State of Louisiana for a period of up to two (2) years, as determined by the LBAB.
6. By agreeing to the terms of this Consent Agreement and Order, MR. COMEAUX waives all rights to appeal his consent to this Consent Agreement and Order or the approval of this Consent Agreement and Order by the LBAB.




