CONSENT CONTINUANCE ORDER

WHEREAS, Joddie Dupuis, LPC (“Ms. Dupuis”) is a Licensed Behavior Analyst (“LBA”), and is subject to the jurisdiction and rules and regulations of the Behavior Analyst Practice Act (La. R.S. 37:1001, et seq.), and the Professional and Occupational Standards for Behavior Analysts (LAC 46:VIII §301, et seq.);

WHEREAS, on October 30, 2023, pursuant to La. R.S. 37:3704(9) and La. R.S. 49:977.3(C), the Louisiana Behavior Analyst Board (“LBAB”) through its Complaints Committee Chair, Courtney Wright, J.D., LBA, issued an Order of Summary Suspension, which had the effect of summarily suspending LBA License number L-382 issued to Ms. Dupuis pending an administrative hearing scheduled for November 9, 2023, at 10:00 a.m.;

WHEREAS, counsel for Ms. Dupuis requested that the hearing on the continuation of the Order of Summary Suspension be continued to a later date to allow the parties sufficient time to address a potential resolution of the matter;

WHEREAS, during the regular meeting of the LBAB on November 15, 2023, the Board was notified that the respondent, Ms. Dupuis, through counsel, requested that the hearing on the continuation of the Order of Summary Suspension be continued to a later date;


WHEREAS, a motion was made and unanimously affirmed by the LBAB to continue the hearing on the continuation of the Order of Summary Suspension relative to Ms. Dupuis’ license,

and to continue the effect of the Order of Summary Suspension dated October 30, 2023, until the hearing on the Order of Summary Suspension or further order of the Board.

ORDER

IT IS HEREBY ORDERED that in consideration of the foregoing, the LBAB adopts this Continuance Order. Accordingly, the continuance requested in this matter is granted. The hearing on the continuation of the Order of Summary Suspension issued and signed in this matter on October 30, 2023, will be reset upon the mutual agreement of the parties. Further, the terms of the Order of Summary Suspension issued by the LBAB on October 30, 2023, shall continue in effect until the hearing on the Order of Summary Suspension or further order of the Board.



ACKNOWLEDGMENT OF RESPONDENT


