### **CONSENT AGREEMENT AND ORDER**

On August 20, 2019, the Louisiana Behavior Analyst Board (“LBAB”), pursuant to an Order of Summary Suspension signed August 12, 2019, convened to hold an administrative hearing in Baton Rouge, Louisiana, regarding complaint number 2019-003C regarding its licensee, Jamie Lynn Hebert, license number L-215.

The following board members of the LBAB were present: Scott Williamson, M.A. – Board Member; Lloyd Boudloche, Jr., Ed.D. – Board Chair; Renee Cole, M.A. – Board Member; Calvin Cryers, M.A. – Board Member; and Courtney Wright, M.Ed., J.D. – Board Vice Chair.

Also present were: James R. Raines – Prosecuting attorney for the LBAB; Leslie J. Schiff – Attorney for Jamie Lynn Hebert; Jamie Lynn Hebert; Alicia Edmond Wheeler – General counsel to the LBAB; and Amy Groves Lowe, Hearing Officer.

Upon convening the hearing, the parties herein presented a Consent Agreement to the LBAB, as follows, which agreement resolved the matters set forth in the pending Order of Summary Suspension signed August 12, 2019, which Consent Agreement was unanimously adopted by the LBAB. Therefore, pursuant to the stipulation of the parties, the LBAB adopts the stipulation of the parties, and issues the following Order in this matter:

IT IS HEREBY ORDERED that the summary suspension of the license of Jamie Lynn Hebert, license number L-215, is lifted.


IT IS FURTHER ORDERED that Jamie Lynn Hebert, license number L-215, shall be allowed to retain her license, with the following restrictions:

- a) Subject to the following, Jamie Lynn Hebert shall not be allowed to provide Applied Behavioral Analysis services to clients or register line technicians with the LBAB prior to the December meeting of the LBAB.
- b) Jamie Lynn Hebert shall be evaluated by an independent psychiatrist, chosen by her from a list of three (3) psychiatrists in her area, which list will be provided to her by the LBAB.

- c) Jamie Lynn Hebert shall execute a HIPAA compliant release in order to allow the psychiatrist to obtain and/or access her medical, therapy, and hospitalization records. The psychiatrist shall be allowed to communicate with her treating physicians. The psychiatrist shall provide a report of his/her findings to the LBAB as well as to counsel for Jamie Lynn Hebert.
- d) Jamie Lynn Hebert shall continue in therapy with her current therapist, who shall provide monthly reports of Jamie Lynn Hebert's progress and status by the end of each month, beginning in August of 2019.
- e) Any employer of Jamie Lynn Hebert shall be notified of the restrictions contained within this Order and shall acknowledge their adherence to the Order in writing to the LBAB.

IT IS FURTHER ORDERED that Jamie Lynn Hebert shall appear before the LBAB at its December meeting to allow the LBAB to determine whether the terms of this Order have been met by Jamie Lynn Hebert. If all terms herein have been met and the psychiatrist reports that Jamie Lynn Hebert may begin providing Applied Behavioral Analysis services to clients, Jamie Lynn Hebert will be allowed to begin providing such services as of January 1, 2020. However, in the event Jamie Lynn Hebert meets all conditions of this Order in advance of the November meeting of the LBAB, she shall notify the LBAB, thought counsel, and appear before the LBAB at its November meeting to allow the LBAB to determine whether the terms and conditions set forth herein have been met.
