CONSENT AGREEMENT AND ORDER

WHEREAS, JAMIE LYNN HEBERT (“Ms. Hebert”) is a Licensed Behavior Analyst (“LBA”), and is subject to the jurisdiction and rules and regulations of the Behavior Analyst Practice Act (La. R.S. 37:1001, et seq.), the Professional and Occupational Standards for Behavior Analysts (LAC 46:VIII § 301, et seq.), the BACB Professional and Ethical Code for Behavior Analysts, and the rules regarding disciplinary proceedings (LAC 46:VIII § 601, et seq.); and

WHEREAS, on August 12, 2019, a Summary Suspension Order was signed in this matter, suspending the LBA license of Ms. Hebert pending a hearing before the Louisiana Behavior Analyst Board (“LBAB”);

WHEREAS, on August 20, 2019, at the scheduled hearing before the LBAB, the parties entered into a Consent Agreement and Order, which was approved by the LBAB;

WHEREAS, on September 19, 2019, the Consent Agreement and Order was signed by the Chair of the Louisiana Behavior Analyst Board (“LBAB”), which Agreement provided for the reinstatement of the license of Ms. Hebert, but set forth certain restrictions regarding her license as agreed to by the parties at the August 20, 2019 hearing;

WHEREAS, the undersigned Prosecutor for the LBAB has had further communications with Ms. Hebert, who has indicated that it is her desire to resolve this matter through a Consent Agreement and Order as provided for in LAC 46:VIII § 603 and La. R.S. 49:955(D) of the Louisiana Administrative Procedure Act;

WHEREAS, Respondent, Ms. Hebert, recognizes her right to have an Administrative Adjudication of the charges outlined in the complaint and notice letter, at which time Ms. Hebert would be entitled to be represented by legal counsel, to call witnesses, and to present witnesses on her behalf in defense or in mitigation of the charges made, and to a decision thereon by the LBAB based upon written findings of fact and conclusions of law in accordance with the

Louisiana Administrative Procedure Act. Ms. Hebert nonetheless hereby waives her right to formal adjudication and, pursuant to La. R.S. 49:955(D), consents to the entry of the Consent Agreement and Order set forth hereinafter. Ms. Hebert also acknowledges that she hereby waives any rights to which she may be entitled pursuant to the Louisiana Administrative Procedure Act, La. R.S. 49:951, et seq., or which she otherwise may be afforded by any law to contest her agreement to, or the force and effect of this Consent Agreement and Order in any Court or other forum.


IT IS HEREBY ORDERED that in consideration of the foregoing and pursuant to the authority vested in the LBAB by La. R.S. 49:955(D), the LBAB orders and Ms. Hebert accepts the following administrative action, which is a final decision pursuant to La. R.S. 49:958:

1. Ms. Hebert agrees that she will not provide Applied Behavior Analysis services to clients or register line technicians with the LBAB for the remainder of 2019, and will allow her license to lapse for 2020. She will not seek renewal of her license prior to the November 2020 meeting of the LBAB.
2. Prior to any request for renewal of her license, Ms. Hebert agrees to provide to the LBAB clinical notes, reports and records from her current counselor (or treating counselor at that time), as well as any physician or nurse practitioner providing treatment to her, and records regarding any hospitalizations, treatment plans, or her adherence to same, and agrees to sign any necessary releases to allow the release of such records to the LBAB.
3. MS. HEBERT shall also obtain the necessary continuing education hours required for renewal of a license prior to seeking renewal of her license with the LBAB.

THIS CONSENT AGREEMENT AND ORDER shall take effect immediately upon adoption by the LBAB and is a matter of public record. The terms of this Consent Agreement and Order may be published and reported in, including but not limited to, the LBAB website, the BACB, and the National Practitioners Data Bank (NPDB).


